


Job Description and Person Specification

JOB PURPOSE

To provide out of school activities within the Club for children attending the school.

This job falls within the definition of regulated activity and therefore would be subject to an Enhanced DBS with barred list check.



MAIN DUTIES AND RESPONSIBILITIES

- Assist the children and young people to access the club within a safe environment
- Respond to the individual needs of the children and young people
- Be part of a team providing a nurturing and stimulating environment
- Lead activities as required by the Club Manager/Leader or Deputy e.g. art activities, cooking, sports or to be responsible for a room where the activity is child led
- Ensure a friendly, positive and supportive atmosphere is maintained by using strategies to support children in managing their own behaviour. To follow any behaviour plans that are used in the Club
- Adhere to any Club Policies and procedures and good working practice under the direction of the Club Manager / Deputy
- Maintain a professional manner following the School Code of Conduct at all times with pupils, staff and families
- Record accident and incidents as required in a timely and accurate manner
- Ensure materials and equipment are kept clean and safe
- Help set up activities and clear away at the end of the session
- Be willing to attend appropriate training sessions
- Maintain confidentiality at all times within the Club and outside this environment
- Participate in staff meetings and evaluation as directed
- Carry out any other duties that may be required or as directed
